Honorary membership was bestowed upon Monroe E. Wall at the 28th Annual Meeting of the American Society of Pharmacognosy. Dr. Wall's career has spanned 50 years since his graduate student days, having received his B.S. in Chemistry from Rutgers University in 1936, his M.S. in Chemistry and Ph.D. in Agricultural Biochemistry also from Rutgers in 1938 and 1939 respectively.

Shortly after his graduation in 1939, Monroe Wall joined the Eastern Regional Research Laboratories of the U.S. Department of Agriculture where he remained until 1960. At that time, he joined the newly formed Research Triangle Institute where he rose through the ranks until he became the Chief Scientist at RTI in 1983. He is presently in that position which is highly research oriented.

Dr. Wall's distinguished career in natural products research includes work in isolation, characterization, synthesis, metabolism, and pharmacology of those substances.


President McChesney Receives Gavel

For obvious reasons, much of the committees functions requires absolute secrecy. ## ASP AWARDS AND GRANTS PROGRAM FOR 1987 ANNOUNCED

To stimulate interest in all phases of natural products research, the American Society of Pharmacognosy is offering the following awards and grants:

#### 1. Research Starter Grants:

Members of the Society who are within the first five years of assuming their first professional position are eligible for a grant of \$2000 to \$5000 to aid in their research. These grants will not provide overhead monies to the grantee institution. Applications are due February 1, 1988.

#### 2. Travel Grants for Active Members:

Members of the Society who are within the first five years of assuming their first professional position are eligible for a grant of \$300 to \$500 to enable them to present a paper at an annual meeting of the Society. Applications are due May 1, 1988.

## 3. Travel Grants for Graduate Students:

Graduate students under supervision of a Society member are eligible for a grant of \$300 to \$500 to enable them to present a paper at an annual meeting of the Society. Applications are due May 1, 1988.

#### 4. Undergraduate Research Awards:

Undergraduate students interested in investigating a career in natural products research are eligible for a research award to study under the direction of a Society Member on the faculty of an American college or university. These awards (\$2000 to the student and \$500 to the advisor) do not provide overhead monies to the grantee institution. The research project is to be accomplished in a summer during the student's academic program leading to the B.S. or Pharm.D. degrees. Applications are due February 1, 1988.

Editor James E. Robbers has reported to the membership the progress that the Journal has made over the last vear. The Journal continues its growth with another increase in the number of manuscripts received over last year. The total number received this year was 412, an increase of 37 over last year. The number of manuscripts published increased by 50 over last year with a total of 295 this year. The increase in papers published was mostly in the areas of "full papers" and "brief reports". The editors again wish to thank the dedicated referees who provide their time, effort, and expertise in helping produce a quality journal. In addition, the editors send a special thanks to the members of the Editorial Advisory Board who submitted manuscripts to help make the 50th anniversary issue a memorable

Once again, Editor Robbers, Associate Editors Kingston and McLaughlin, Managing Editor Stites, and the entire editorial staff have done an excellent job.

## KILMER PRIZE NOMINATIONS BEING ACCEPTED

Dr. Schultes was also awarded an honorary D.Sci. in Pharmacy on June 7, 1987 from the Massachusetts College of Pharmacy.


