Place: Amsterdam, The Netherlands

Venue: Main Building Vrije Universiteit Amsterdam (VU), De Boelelaan 1105, Amsterdam, situated at 5 min walking distance from the Amsterdam-Zuid/World Trade Centre railway station, about 10 min by tram from the center of town, 10 min by train from Amsterdam Schiphol Airport (7 km by car). There are several big hotels close to the university. Registration: Registration will be handled by the VU Conference Service (address below). Your reservation for accommodation can be arranged through Carlson Wagonlit Travel (address below). Your abstract should be sent to the Organizing Committee (address below). Registration fees after June 15:

The registration fee includes welcome drinks on Monday July 26, the reception on Tuesday July 27, coffee and tea during the breaks, the book of abstracts, and one public transportation ticket for use of bus, tram and metro in Amsterdam for the time of the meeting.

Meals: Lunches can be bought at one of the restaurants in the VU buildings. For dinner, ample restaurants can be found in Amsterdam city center.

Congress dinner: On Friday evening the congress dinner will be in Volendam, a small fishing village north of Amsterdam. The price of the dinner (NLG 120) includes a visit to Marken, a former island and fishing village in the IJsselmeer, a boat trip from Marken to Volendam, and transportation back by bus

Language: The official congress language will be English. There will be no translations.

to Amsterdam.

Exhibition: There will be an exhibition during the meeting.

Excursions: Various excursions will be arranged during and after the meeting.

Climate: In July the weather is mild with daily temperatures ranging between 18° and 30° C, with always a chance of rain.

Travel: Amsterdam can be reached by car, train and air plane. Schiphol Airport is 10 min by train from the congress venue. The Amsterdam-Zuid/World Trade Centre railway station is 5 min walking from the congress venue. By car the Vrije Universiteit can be reached from the Motorway A10, exit S108 Hospital Vrije Universiteit (H VU), Zuid/Amstelveen. Turn left at the end of the split road onto Amstelveenseweg, after about three hundred meters (at the Hospital VU) turn left again onto De Boelelaan. The VU can be reached via city routes S108 and S109. All participants will receive a ticket for free public transport in Amsterdam (bus, tram, metro) for the time of the meeting.

Parking: Parking in the city of Amsterdam is difficult. At the congress venue there are only limited parking facilities (all paid parking), there is a parking garage at the VU hospital close to the congress center. A number of parking places for the handicapped are reserved in front of the VU Main Building and within its grounds.

Currency: The Dutch currency is the guilder, the exchange rate is 1 US \$ for about NLG 2.00, 1 Euro for about NLG 2.20. All major credit cards are widely accepted.

Visa: Participants who need an entry visa are advised to make the application with the Dutch Embassy or Consulate in their home country at least two months before the intended arrival date. If required for a visa or for raising travel funds, a letter of invitation can be obtained from the Organizing Committee (address below); such a letter is not a commitment on the part of the organizers to provide any financial support.

FROM THE PRESIDENT

WHEN IT COMES TO DIVERSITY, NATURE COMES OUT AHEAD

I'm sure many of you who receive Chemical and Engineering News saw the above headline in the March 29 issue (p. 28). As reported by Pamela Zurer, some researchers at Bayer in Germany have performed a statistical investigation into the structural similarities of natural products and synthetic compounds [reported in the March 1 issue of the International Edition of Angewandte Chemie (p. 643)]. The investigation was prompted by the observation that, with the recognition of the strengths of combinatorial chemistry, "quite a few people predicted that natural products will simply be substituted by synthetic compounds". On the basis of their evaluations, the Bayer scientists concluded

that there is a clear difference between the structural properties of natural products and synthetic compounds. The section head of natural products chemistry at Bayer, Dr. Thomas Henkel, states: "Nature is and will be the more efficient and talented source of innovative lead structures. Even anticipating strong progress in synthetic methodology, it is hard to imagine that combinatorial synthesis will ever substitute for natural products"

The group of eminent scientists who recently reviewed the NCI Developmental Therapeutics Program also noted that "natural products have proven to be the most effective small molecules in terms of their ability to alter the function

of proteins relevant to cancer", and that "by continuing the discovery of new anticancer natural products and by applying the insights derived from the study of these natural products to the design and construction of synthetic molecules, it should be possible to develop new anticancer agents".

To me, it is significant and encouraging that there continues to be the recognition by experts in industry, academia and government, of the immense value of natural products as an important source of leads in drug discovery and development. Rather than taking a confrontational attitude to technologies such as combinatorial chemistry, and feeling

THE MATT SUFFNESS SYMPOSIUM

As many ASP members know, the late Matt Suffness was a driving force behind establishing the "Young Investigators' Symposium" as a forum for younger natural products scientists to present the results of their research and gain timely recognition from their colleagues for their contributions to the science.

At the annual meeting of the ASP in Orlando in 1998, several members questioned the use of "young" in the title, and after thorough discussion, the ASP Executive Committee has unanimously decided to rename the Symposium, "The Matt Suffness Symposium." The Symposium will be held at annual Society meetings in the Unites States, with the first one being in Seattle in 2000.

The Awards and Funds Committee has been charged with the selection of speakers according to the following procedure:

- 1) The number of speakers per year shall be limited to two, but may be one or none if suitable nominations are not received in a particular year.
- 2) Nominees must be ASP members.
- 3) The age limit of nominees shall be 40 years.
- 4) Nominees shall be within 12 years of receiving their Ph.D., and within 10 years of gaining their first independent position (e.g., Assistant Professor or equivalent position in industry and government).
- Nomination paperwork shall be kept as simple as possible. The Awards and Funds Committee will prepare a Nomination Form for use in soliciting nominations.
- 6) A nomination must be accompanied by the nominee's CV, an abstract of the presentation proposed by the nominee, and relevant reprints. Selected speakers will be invited to submit a short review paper to the *Journal of Natural Products*.
- 7) Nominations will be solicited in the Newsletter, on the Website, and from recipients of the Research Achievement Award. Self-submissions will not be accepted.
- 8) Nominations will only be accepted from active ASP members.
- The Awards and Funds Committee must keep in close contact with the appropriate ASP meeting Scientific Program Committee.
